Preamble

The Bayard Group attaches great importance to respecting privacy and regulations regarding the processing of personal data. This Privacy Policy informs you about how your personal data is processed in your capacity as a customer, subscriber, prospect, or user of our products and services, including content and services offered through websites and applications, newsletters, or events, as well as the collection of donations ("Services").

This Privacy Policy may change at any time. Changes take effect on the date they are posted online.

The Bayard Group Privacy Policy applies in addition to the General Terms of Use and General Terms of Sale of the sites or applications where they exist, as well as the information notices communicated to you.

I. Who are the data controllers of your personal data?

The Bayard Group is a publisher and provider of services, available on various physical or online media, which operates in particular in the following areas of activity: press, publishing, audio, audiovisual, applications and platforms, media services, events, advertising sales, travel.

II. What personal data is collected as part of our Services?

1. Data collected from you

The Bayard Group collects and processes the personal data necessary for the processing purposes described in this Privacy Policy.

The personal data processed by the Bayard Group may include:

Identification and contact data, such as name, surname, title, postal address, email, telephone number, date of birth, identifiers, or, where applicable, proof of identity to exercise your rights, communication options;

Data relating to your personal situation, such as family situation, household composition, interests, preferences, comments, opinions, photos, videos, audios, recorded calls;

Commercial and billing data, such as your order history, exchanges with customer service, data necessary for prospecting, survey or statistical activities, means of payment and/or bank details;

Navigation data, such as connection, activity and usage data relating to the Services (page loads, button clicks, click-through rates on newsletters, banners, etc.) or geolocation data.

Cookies, other tracking technologies, or similar technologies (hereinafter referred to as "cookies") may be placed and/or read when you use our Services. For more information, please see Chapter VII, "Cookies and Trackers."

When your data is collected via a form, you are notified whether the information requested is mandatory in order to benefit from a Service, or whether it is optional (without an asterisk).

Your data can be linked together and by combining the data we have, we can make inferences about your interests in order to offer you tailored deals.

2. Data collected from third parties

In certain circumstances, we may collect personal data from third parties.

These third parties are business partners or other companies in the Bayard Group with whom you have been in contact and authorized to share personal data about you with us, or public sources.

3. Data of minors under 15 years of age

If you create an account on one of our sites in the name of your child, in your capacity as holder of parental authority, you are informed that the personal data relating to your child under 15 years of age will be processed and used by the Bayard Group in accordance with this Privacy Policy.

If your child is under 15 years of age, and their consent is required for the processing of personal data, you will be asked, as the holder of parental authority, to consent to the processing of your child's data by the Bayard Group.

4. Data concerning a third party

If you offer a third party a Service provided by us, you must first ensure that this person agrees to the necessary data being communicated to us and processed in accordance with this Privacy Policy.

III. For what reasons does the Bayard Group process your personal data?

Your data is collected and processed by the Bayard Group for the following main reasons:

- **Managing your orders and providing our Services**, including:
 - creation and management of your account, registration, management, delivery and tracking of your order, registration and access to our Services, management of loyalty programs, management of your donations, accounting management, contracts, invoices, payments and means of payment, customer service management, management of unpaid invoices and disputes as well as the fight against fraud, sending of newsletters and informational messages relating to your order and provision of the Services to which you have subscribed or included in your subscription, management of comments and reviews, management of your participation in our events, competition games, carrying out of studies and surveys, personalization of our communications and display of advertising to finance free access to certain Services,
 - analysis, administration and improvement of our Services and activities, including statistics, quality and security of our Services, etc.
- **Promoting our Services** through marketing and sales prospecting activities, including targeting via various communication channels, digitally (including email, mobile or or online displays on Bayard Group websites or via partners, such as advertising platforms or social networks), by phone (including SMS and similar technologies), by mail or any other medium, including:
 - Provision of commercial offers, which can be personalized; offers for products and services similar to those you have already ordered.
 - Postal standardization, updating, enrichment and deduplication of your personal data.

In all cases, you can withdraw your consent to receive commercial offers from the Bayard Group by email or object to commercial prospecting based on legitimate interest under the conditions set out in Chapter X.

- **Promotion of their products and services by Bayard Group partners** , through commercial prospecting activities, including fundraising, by email, phone, or mail, including:
 - Sharing, exchanging or renting files, in compliance with current regulations and security requirements; sending promotional messages or displaying of advertisements, which may be (or not) personalized.
 - Implementation of partnership operations (competition games, events, etc.)

In all cases, you can withdraw your consent to receive commercial offers from our partners by email or object to commercial prospecting by post or phone, based on legitimate interest, under the conditions set out in Chapter X.

- **Exercise of your rights and any processing required to meet our legal obligations,**
- **Defending our interests in the event of a dispute or legal action.**

IV. What are the legal bases for the processing of your personal data?

The Bayard Group processes your personal data in accordance with applicable regulations, based on the following grounds:

- Execution of a contract concluded between you and one of the companies of the Bayard Group (in particular for order management and provision of subscribed Services),
- Compliance with a legal obligation,
- Your consent to the use of your personal data (by ticking a dedicated box, for example), it being specified that you can withdraw your consent at any time,
- Existence of a legitimate interest of the Bayard Group or a third party, justifying the use of your data in compliance with your rights and interests.

V. How long is your personal data kept?

The retention period for your personal data may vary depending on the purpose of the collection.

Your data will only be kept for as long as necessary to achieve the intended purpose.

Your personal data may be kept beyond the aforementioned periods to meet our legal obligations or for evidentiary purposes. After this period, it will be deleted.

VI. Who are the recipients of your personal data?

The personal data collected is intended for the Bayard Group. It may be transmitted to the following third parties:

- **Bayard Group's service providers and subcontractors**, in particular for the purpose of providing the requested Services, including shipping, delivery and management of your subscriptions and orders, troubleshooting Service malfunctions, payment processing, data analysis, marketing activities, hosting of the Services, and providing development, maintenance, consulting and support services,

- **The companies of the Bayard Group**, within the framework of the centralized management of some of our activities and for the purposes, where applicable, of analyzing, administering and improving our Services,
- **Potential buyers**, in the event of a change of control of the Bayard Group companies or the sale of all or part of its assets,
- **The commercial partners of the Bayard Group** for the purpose of promoting their products and services, under the conditions set out below:

VII. Cookies and trackers

Cookies and other trackers or similar technologies (hereinafter referred to as "cookies") may be placed, subject to your specific consents where required, on your device (computer, smartphone or tablet for example) when you use our Services.

1. What is a cookie?

A cookie is a text file that records information about your browsing activity on the internet or in an application. It is placed on the user's device by the server during a visit to the website. Similar technologies allow for reading or writing information on a user's device and, in combination with the use of cookies, tracking their activity on the internet or in an application. Some cookies are essential for using the Services, while others help optimize and personalize the displayed content.

The Bayard Group uses cookies for various reasons. A cookie allows us, in particular, to send you personalized offers, to identify you when you access your customer account, to keep items in your shopping cart after you log out, but also to indirectly finance the free services we offer and which are provided to you by our various services.

2. What cookies does the Bayard Group use?

- **Functional cookies**

These cookies are placed exclusively by the Bayard Group and are necessary for the proper functioning of the Services you use, as well as for accessing features designed to ensure your browsing comfort. They cannot be refused.

They allow us, for example:

- to implement security measures, for example when you are asked to log in again to access content or a service after a certain period of time;
- to access reserved and personal areas, such as your account, using identifiers or data that you have previously provided to us;
- to remember your cookie preferences.
- **Audience measurement cookies exempt from consent**

Our Services use audience measurement cookies to compile anonymous statistics and traffic and usage volumes (sections and content visited, browsing paths, etc.), allowing us to improve the relevance and usability of our Services.

- **Advertising cookies**

3. How to express your choice?

- Use the consent management platform that is offered to you when you first log in to the site.

You can at any time find out more and configure your cookies to accept or refuse them by going to the "Manage cookies" or "Manage consent" link on our Services.

On the first page of the consent management platform, you will find general information about the purposes of the different cookies used on the site. You can either:

- Accept all cookies and continue browsing;
- Continue browsing without accepting trackers. In this case, cookies requiring consent will not be activated;
- Configure your choices:
 - On the second page of the consent platform, you can exercise your choices based on each purpose for data collection by cookies and trackers placed by the website or application. You can click on "Accept all" or "Reject all" and continue browsing, or configure your choices regarding partners.
 - On the third page, you can configure your choices by partner.

Your consent is valid for twelve (12) months. Please note: your choice can only be saved if you use the same browser and have not cleared your cookies in the meantime. You will be asked again each time you clear your cookies, or every twelve (12) months, or six (6) months after you refuse cookies.

However, free access to certain websites and applications with editorial content (excluding subscriber-only content) requires consent to the use of your personal data to fund content produced by journalists dedicated to providing you with quality information. The websites concerned

- Configure your browser

Most browsers accept cookies by default. However, you can choose to block these cookies or have your browser notify you when a website tries to place a cookie on your device. In this context, we inform you that you can configure your browser to refuse the placement of cookies. Each browser has a different configuration for managing cookies and your preferences. This is described in your browser's help menu, which will explain how to modify your cookie settings.

If you are using Explorer browser: click the Tools button, then Internet Options. On the General tab, under Browsing History, click Settings. Then click View files and select the cookie(s) you wish to disable. Close the window containing this list of cookies and click OK twice to return to the internet.

VIII. How is your personal data protected?

The Bayard Group implements appropriate technical and organizational measures to protect your personal data against alteration, accidental or unlawful loss, disclosure or unauthorized access, and in particular:

- Appointment of a data protection officer (DPO) and an information systems security officer (RSSI),
- Employee awareness sessions about personal data protection and cybersecurity,
- Securing access to premises and information systems,

IX. Is your personal data transferred abroad?

In order to ensure the execution of its services and in particular the management of subscription and renewal information flows as well as customer service, the Bayard Group may transfer your personal data to subcontractors located outside the European Union, and in particular in Madagascar.

For the purposes of hosting and statistical analysis of our Services, your data may be transferred to the United States.

In this case, we implement the safeguards provided for by the applicable regulations to ensure an adequate level of protection for the transferred data, by signing the standard contractual clauses established by the European Commission or by ensuring that an adequacy decision is in force with the country of destination of the data.

X. How to exercise your rights?

1. Your rights regarding marketing communications by the Bayard Group and/or its partners

You can unsubscribe from communications and newsletters sent by email using the unsubscribe link that you will find at the bottom of all commercial emails from the Bayard Group.

You can disable notifications on mobile apps in your smartphone's settings.

For SMS, you can send a STOP by replying to the message at the number indicated in it.

In accordance with Law No. 2014-344 of March 17, 2014 relating to consumer affairs, you can object to telephone solicitation by registering on the national opt-out list "Bloctel" (<https://www.bloctel.gouv.fr/>). The Bayard Group would like to inform you, however, that exceptions exist. Indeed, the law allows you to be contacted if:

- You are our customer;
- You gave your number unequivocally;
- The phone call consists of offering you the supply of newspapers, periodicals or magazines or contributing to a charitable action carried out by a non-profit association.

2. Exercising the rights of access, rectification, erasure, objection, data portability, restriction of processing, and to know the fate of one's data after death

Depending on the legal basis justifying the processing of your personal data, you may exercise [all or part of the following rights](#) :

- Right of access: you can request access to your personal data;
- Right to rectification: you can request that your personal data be rectified, completed or updated as appropriate;
- Right to restriction: you can, within the limits provided by the regulations, request to limit the processing of your personal data, for example for the time required to correct incorrect data;
- Right to data portability: within the limits of the technical processes used by the Bayard Group, you can request to receive your personal data in a structured, commonly used and machine-readable format, and to have it transmitted to another data controller, for processing carried out using automated processes for which you have given your consent;
- Right to object: you can object to data processing based on the legitimate interest of the Bayard Group, such as commercial prospecting (See 9.2);
- Right to erasure: you can, within the limits provided by the regulations, request the erasure of your personal data;
- Withdrawal of consent: when the processing of your personal data is based on your consent, you have the right to withdraw your consent at any time;
- Right to know the fate of your data after death: you have the right to define guidelines regarding the fate of your personal data after your death.
